In consideration of the granting of this permit, the undersigned agrees to accept and abide by all provisions of the City of Eminence Water/Sewer Departments and all other applicable ordinances or regulations. The undersigned also agrees to maintain the building's sewer at no expense to the City, and to notify the Superintendent when the building's sewer has been installed and is ready for inspection but before any portion of

the work is covered. The undersigned further agrees to abide by Ordinance 94-004, Sections 16 and 20, which reads as follows:

Section 16 – Any authorization for a hook-up to the sewers of the City of Eminence, Kentucky, shall expire and be voided if not exercised by making an actual hook-up to the said sewer within 180 days following said authorization and payment of fee for hook-up. Any fee paid for a hook-up not so exercised within the prescribed period shall not be refundable and shall be forfeited to the City of Eminence, Kentucky, except upon petition made by the person holding said authorization prior to the said expiration, the City Council may grant extensions of time for making such hook-ups for such periods as the City Council is its sole discretion deems appropriate. NOTE: Said 180 day time period is not an extension of time for mandatory connection. All business and residential structures are required to connect at time of occupancy unless an undue hardship is recognized on petition to the Eminence City Council.

Section 20 – The term “installation” as used in this and all ordinances of the City of Eminence, Kentucky, regarding sewers, sewer lines, water and water lines shall be interpreted by the City Council to encompass and include in its meaning all maintenance of said sewers, and sewer lines, to City main and water, and water lines to City meter except as is specifically contradicted in any such ordinance. Sewer main shall mean sewer line located between manholes and service lines shall mean any branch off the sewer main.
