The City Council of the City of Eminence, Kentucky met in regular session on Monday, December 9, 2024, at 6:00 p.m. with Mayor Fred Downey and the following members present: LeeAnn Armstrong, Phillip Smith, Karen Paris, Justin Wayman, and Connie Nation. Absent was Member Bobbi Jo Frazier. Also, in attendance were City Attorney Chelsey Brammell, City Clerk Robin Mullins, Interim Police Chief Scott Wilcoxson, Public Works Director Matt McAllister, Fire Chief Steve Lucas, Employees: Troy Popp, J.R. Ellis, Brett Downey, Resident DeAnne Downey, Henry County Local Editor Joe Durbin, and Magistrate Carl Tingle.

Mayor Downey called the meeting to order at 6:00 p.m.

OLD BUSINESS

Subject: Minutes – The minutes of the previous special session held on November 12, 2024, were reviewed. Mayor Downey asked for any additions or corrections to the minutes. Motion made by Member Armstrong and seconded by Member Smith to approve the minutes as presented. On a call for votes, all members present voted "Yea".

Motion made by Member Paris and seconded by Member Smith to approve the resolution providing the sale of a Franchise for the business of the collection and disposal of garbage, trash, and debris within the city of Eminence. On a call for votes, all members present voted "Yea".

Subject: Authorizing Resolution for CBDG Grant for the Sewer Expansion. Motion made by Member Armstrong and seconded by Member Paris to authorize Mayor Downey to sign on behalf of the City of Eminence all documents related to the CBDG Grant for Sewer Expansion. On a call for votes, all members present voted "Yea".

Subject: Municipal Order Updating the City of Eminence Employee Handbook with provisions for Medicinal Cannabis. Motion made by Member Armstrong and seconded by Member Smith to approve the Municipal Order updating the City of Eminence Employee Handbook with provisions for Medicinal Cannabis. On a call for votes, all members present voted "Yea".

Mayor's Update: Mayor Downey reported a zone request was put in the packet for property on Ballardsville Road asking for a change from A1 to A2. The plan is to put 60 homes in.

Also, Mayor Downey reported Officer Corley has been promoted to Sergeant and Officer Downey had been promoted to Detective.

Mayor Downey reported the city has applied for CPPP Road Grants to pave Blackaby Lane and Crabb Avenue.

Mayor Downey reported the city had been approved for the state portion of the Land and Water Grant for the mulch replacement, but we are still waiting to hear on the federal portion.

Council - New Business – Member Armstrong reported how good the community room looks and there are seven or eight rental applications for the next couple of months.

Also, Member Armstrong reported CVS plans to use the community room for their district meetings each quarter.

Member Paris wanted to thank Public Works for the lights and all the work on the Christmas tree. There were around 3,000 or more people here for Light Up Eminence. Santa Claus will be here Friday, December 13^{th} from 6:00-8:00 p.m.

Member Wayman asked us to keep Steve Metcalfe in our prayers.

With no further business to be discussed, the motion made was by Member Smith and seconded by Member Nation to adjourn. All members present voted "Yea". The meeting was adjourned at 7:16 p.m.
