# **SEWER EXPANSION PROJECT:**

The City's sewer expansion project to allow for more capacity is progressing smoothly. The sludge removal from the lagoons is now complete. Construction to upgrade equipment and make our system more efficient and also increase our capacity from .5 MGD to .75 MGD is scheduled to start soon. Completion, weather permitting, is still scheduled for late winter. As a reminder, the City has received a \$647,000.00 CDBG grant and a \$350,000.00 HB 608 grant to do this work. Other funds needed will be taken from local reserve funds or a low interest loan. No additional increase in water and sewer rates are expected other than the normal annual increase of 1-1/2 percent. Any questions, please feel free to give us a call.

# Not So "Flushable"

A public announcement by Matt McAllister, City of Eminence Wastewater Plant Facility Operator

Many things will flush down the commode with a jiggle of the handle. However, most people don't understand the affect it has on a sewer system once it leaves their home. What you flush makes a long winding journey to the City's Wastewater Treatment Facility.

There are many obstacles along the way. The sewer collection system is made up of piping, joints, traps, elbows, service taps, manholes, floats, pumps, bar screens, etc... These obstacles are not an issue for typical flushable items like toilet tissue that are designed to break down almost instantly. They are however a major hurdle for objects that claim to be flushable but don't share the same disintegrative properties.

and improved product can be flushed without issue. This is not the case. Sure, a lot of things can be flushed down the commode but where does it end up after that? A simple small tree

root that has made its way into your service line can act as an anchor for that wipe or feminine product. Consider if you flush 10 per day and they all hang up on that same tree root. By the end of the week, you have a major blockage comes a large in your service line which could cause septic sewer to back up into your home. wastewater This is going to cost you time and money in major repairs and unsightly lawn damage. If the product even makes it out of your sewer service line, you can bet it doesn't make it much further.

If those items claimed to be flushable do finally make it out of your line and into our collection system, it faces a whole new set of difficulties. The City's wastewater travels through gravity sewer mains into sewer lift pumping stations which then makes its way to our wastewater facility. Inside these pumping stations are wires, chains, pumps, and brackets all ready to snag and hold onto any non-deteriorating object that floats by. On occasion the weight of the accumulated wipe or pad can even be enough to snap electric wires that provide the power to the floats and Pump locked up with accumulatio pumps. The collection of these non-deteriorating products inside our pumps will either of supposed "flushable" wipes greatly reduce its pumping ability or lock it up completely. This results in the City spending thousands every year in pump repairs, manpower, and equipment maintenance. We also spend a great deal of time and



money unblocking clogged gravity lines and backed up sewer manholes.

Eminence, like other municipalities is subject to rules and regulations set forth by the State of Kentucky as well as the Federal Environmental Protection Agency. Increases in overflows caused by these blockages as well as hindering the effectiveness of the sewer collection system can result in issued violations from these governing bodies. This in turn costs the City and you the tax payer, time and money.

In conclusion, please be mindful of what you flush. The big wipe and feminine product manufacturers are unaware of the impact it has on sanitary sewer systems. That \$5.00 package printed "flushable" costs a lot more in the long run. This issue affects everyone. The added expenses and negative impacts these non-flushable items have on our sanitary sewer system is significant. If the problem is not alleviated soon, these extra expenses will likely be passed on to you, the tax payer. Please dispose of them accordingly to save yourself and the City a lot of time and money resolving the issues they cause.
